Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Chicago Public Schools, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Fence(s) on the public right-of-way adjacent to its premises known as 2330 W. Mclean Ave..

Said Fence(s) atW. McLean measure(s):

One (1) at five hundred ninety-nine point nine two (599.92) feet in length, and point two one (.21) feet in width for a total of one hundred twenty-five point nine eight (125.98) square feet.

Said Fence(s) at N. Oakley measure(s):

One (1) at two hundred seventeen point six six (217:66) feet in length, and point two one (.21) feet in width for a total of forty-five point seven one (45.71) square feet.

Said Fence(s) at W. Dickens measure(s):

One (1) at five hundred ninety-nine point five (599.5) feet in length, and point two one (.21) feet in width for a total of one hundred twenty-five point nine (125.9) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and trie Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1145346 herein granted the sum of zero (\$.00) per annum in advance.


