MAC Property Management, LLC Acct.  
No. 387132 - 10 Permit No. 1139234

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to MAC Property Management, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Banner(s) projecting over the public right-of-way adjacent to its premises known as 5500 S. Cornell Ave..

Said Banner(s) at S Cornell measure(s):

One (1) at one point six seven (1.67) foot in length, and one point six seven (1.67) foot in width for a total of two point seven nine (2.79) square feet.

Said Banner(s) at E 55th measure(s):

One (1) at two point five (2.5) feet in length, and twenty (20) feet in width for a total of fifty (50) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1139234 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
