**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-2, Community Shopping District symbols as shown on Map No. 6-J in the area bounded by:**

**West 27<sup>th</sup> Street; South Lawndale Avenue; a line 73 feet South of and parallel to West 27<sup>th</sup> Street; a public alley next West of and parallel to South Lawndale Avenue.**

**To those of a C2-2, Motor Vehicle-Related Commercial District**
