ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the M2-3 Light Industry District symbols and indications as shown on Map No. 1-F in the area bounded by

beginning at a point 278.41 feet north of West Grand Avenue and the east right-of-way line of the alley next west of and parallel to North Union Avenue; a line from a point 278.41 feet north of West Grand Avenue and the east right-of-way line of the alley next west of and parallel to North Union Avenue; to a point, 60 feet north of West Grand Avenue and 57.64 feet west of North Union Avenue; a line 60 feet north of and parallel to West Grand Avenue, a line 68 feet west of and parallel to North Union Avenue; West Grand Avenue; a line 181 feet west of and parallel to North Union Avenue; a line 60 feet north of and parallel to West Grand Avenue; and the alley next west of and parallel to North Union Avenue (TOB),

to those of a C1-5 Neighborhood Commercial District and a corresponding use district is hereby established in the area above described.

SECTION 2. Further, Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the C1-5 Neighborhood Commercial District symbols and indications as shown on Map No. 1-F in the area bounded by

beginning at a point 278.41 feet north of West Grand Avenue and the east right-of-way line of the alley next west of and parallel to North Union Avenue; a line from a point. 278.41 feet north of West Grand Avenue and the east right-of-way line of the alley next west of and parallel to North Union Avenue; to a point, 60 feet north of West Grand Avenue and 57.64 feet west of North Union Avenue; a line 60 feet north of and parallel to West Grand Avenue, a line 68 feet west of and parallel to North Union Avenue; West Grand Avenue; a line 181 feet west of and parallel to North Union Avenue; a line 60 feet north of and parallel to West Grand Avenue; and the alley next west of and parallel to North Union Avenue (TOB)

to those of the designation of Residential-Business Planned Development Number _____, which is hereby established in the area described above subject to such use and bulk regulations as are set forth in the Plan of Development herewith attached and made a part thereof and to no others.

SECTION 3. This ordinance shall be in force and effect from and after its passage and due publication.

NO. PLANNED DEVELOPMENT STATEMENTS

1. The area delineated herein as Planned Development Number _____, ("Planned Development") consists of approximately 23,854 square feet of property which is depicted on the attached Planned Development Boundary and Property Line Map ("Property") and is owned or controlled by the Applicant, Wicker Park Apartments, Inc.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal

title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.

3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assigns or grantees, and approval by the City Council.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans. Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Planning and Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part 11 approval, the submitted plans must be approved by the Department of Transportation.

4. This Plan of Development consists of these sixteen (16) Statements: a Bulk Regulations and Data Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; Site Plan; Landscape and Green Roof Plan; Building Elevations (Northeast/North, South/Southeast, and West) prepared by Brininstool + Lynch and dated February 18, 2016 submitted herein. Full-sized copies of the Site Plan, Landscape

Plan and Building Elevations are on file with the Department of Planning and Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

5. The following uses are permitted in the area delineated herein as a Residential Business Planned Development: Multi-unit Residential Dwelling Units located above the ground floor only, ground floor

retail, accessory parking, accessory and related uses.

6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Planning and Development. Off-Premise signs are prohibited within the boundary of the Planned Development.
7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
8. The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance with the attached Bulk Regulations and Data Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of 23,854 square feet.

9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Planning and Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.

10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. The improvements on the property, including the on-site exterior landscaping, as well as the landscaping along the adjacent rights-of-way and all entrances and exits to and from the parking and loading areas, shall be designed, constructed, and maintained in substantial conformance with the Site Plan and the Landscape Plan. In addition, parkway trees shall be planted and maintained in accordance with the Parkway Tree Planting provisions of the Chicago Zoning Ordinance and corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Planning and Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.

11. The Applicant acknowledges and agrees that the rezoning of the Property from M2-3, Light Industry District to C1-5, Neighborhood Commercial District for construction of this Planned Development triggers the requirements of Section 2-45-110 of the Municipal Code (the "Affordable Housing Ordinance"). Any developer of a "residential housing project" within the meaning of the Affordable

Housing Ordinance ("Residential Project") must: (i) develop affordable housing units as part of the Residential Project; (ii) pay a fee in lieu of the development of affordable housing units; or (iii) any combination of (i) and (ii). In accordance with these requirements and the Affordable Housing Profile Form attached hereto as an Exhibit, the Applicant has agreed to make a cash payment to the Affordable Housing Opportunity Fund in the amount of \$100,000 per unit ("Cash Payment"). At the time of each Part II review for the Residential Project, Applicant may update and resubmit the Affordable Housing Profile Form to the Department of Planning and Development ("DPD") for review and approval. If the Applicant subsequently reduces the number of dwelling units in the Residential Project, DPD may adjust the requirements of this Statement No. 11 (amount of Cash Payment) accordingly without amending the Planned Development. Prior to the issuance of any building permits for the Residential Project, including, without limitation, excavation or foundation permits, the Applicant must make the required Cash Payment.

12. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Fleet and Facility Management and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.
13. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
14. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
15. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. All development shall be in substantial compliance with the current City of Chicago Sustainable Development Policy set forth by the Department of Planning and Development. The proposed building shall provide

a vegetated ("green") roof, totaling a minimum of 50% of the net roof area (approximately 11,822 square feet) and obtain LEED certification.

16. This Planned Development shall be governed by Section 17-13-0612 of the Zoning Ordinance. Should this Planned Development ordinance lapse, the Zoning Administrator shall initiate a Zoning Map Amendment to rezone the property C1-5 Neighborhood Commercial District.

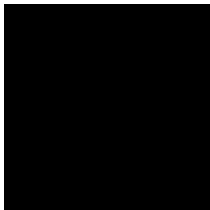

Pursuant to the provisions of the Chicago Zoning Ordinance, Title 17 of the Municipal Code of Chicago, the Department of Planning and Development hereby submits this report and recommendation on a proposed Residential Business Planned Development for your review and recommendation to the Chicago City Council. The application for this amendment to the Chicago Zoning Ordinance was introduced into the City Council on September 24, 2015. Notice of the public hearing was published in the Chicago Sun-Times on February 3, 2016. The applicant was separately notified of this public hearing.

The applicant filed the application as a mandatory planned development per the requirement of section 17-8-0512 Tall Buildings. The applicant proposes to reclassify the site to C1-5, Neighborhood Commercial District prior to establishing the Residential Business Planned Development.

SITE AND AREA DESCRIPTION

The approximately 23, 854 square foot site lies in the West Town (24) Community Area. The triangular shaped site is currently improved by a four (4) masonry buildings with heights ranging from two (2) to four (4) stories. The site is currently M2-3, Light Industry District. The site is neither within the Lake Michigan and Chicago Lakefront Protection District, nor within a Chicago Landmark District but is located in the River West Tax Increment Finance District. The site is bounded on the north and east by the METRA Tracks, on the south by West Grand Avenue, on the west by a public alley. There is a mix of uses along West Grand Avenue that include commercial, retail, institutional and accessory parking.

The site is served by the Chicago Transit Authority bus routes #8 Halsted Street bus line; The CTA's Grand and Milwaukee Blue line station provides access to the area and is located one 1/2 mile west of the site.

PROJECT DESCRIPTION

The applicant proposes to construct a multi-story mixed-use building with ground floor retail, 105 dwelling units, accessory parking and accessory uses. The applicant is seeking an up zoning to a C1-5, Neighborhood Commercial District to a Residential Business Planned Development. The proposal includes the construction of a 9-story (104'-10") residential tower, 6,592 square feet of commercial retail space, and 45 accessory parking spaces. The unit breakdown for the project is as follows: 24 studio units, (49) One-bedroom, and (35) two-bedroom units.

The project has an estimated total project cost of \$20,000,000.00 and the expected construction time line is 18 months. The project is anticipated to generate 100 construction jobs and 20 permanent full time jobs.

DESIGN

The multi-story building is primarily comprised of an architectural composite metal panel system and a Terracotta Rain Screen System. The facades are further defined and glass window system. This architectural vocabulary defines primarily the residential tower fronting West Grand Avenue

elevation. The ground floor contains commercial retail space and fronts West Grand Avenue, and is enclosed by a glass storefront. The residential units are contained on two through nine with the roof top programmed for amenities and mechanical uses. The remaining elevations of the base of the building include scoured concrete and masonry, Cordova Stone ground face.

ACCESS/CIRCULATION

The site has vehicular access via an existing public alley. Pedestrian access for the residential tower is located along West Grand Avenue from a residential entry lobby. The ground floor of the proposed building is designed for commercial retail space fronting West Grand Avenue. The design of the base of the building improves the pedestrian experience and is enlivened by a glass store front facade fronting the street frontage.

LANDSCAPE / SUSTAINABILITY

The project will install new parkway trees along West Grand Avenue (4 trees). The project will comply with the City's Landscape Ordinance. The project will also comply with the Storm Water Management Ordinance, implementing best practices in stormwater management. The project will satisfy the requirements of the City of Chicago's Sustainable Development matrix: The project anticipates receiving building certification and will provide approximately 9,457 square feet of green roof covering 50% of the net roof area.

BULK/USE/DENSITY

The site will be rezoned to a C1-5 District and has a maximum allowable Floor Area Ratio (F.A.R) of 5.0. This proposed Residential Business Planned Development will achieve an F.A.R of 4.25. Based on the project's net site area of 23,854 square feet the blended Minimum Lot Area would permit 105 dwelling units under the C1-5 District.

The developer has opted to reduce the FAR of the building from a 5.0 FAR to 4.25 FAR to permit the scale and bulk of the building to be in character with the surrounding area.

RECOMMENDATION

The Department of Planning and Development has reviewed the project materials submitted by the applicant and has concluded that the proposed application for a Residential Business Planned Development would be appropriate for the site and that the project meets the review criteria for planned developments set forth in the Zoning Ordinance (Section 17-13-0900).

1. The project complies with the Standards and Guidelines for Planned Developments in the Zoning Ordinance (Section 17-8-0900).
 - a. Compliance with Zoning. The proposed building would conform to all the requirements and restrictions of the C1-5, District for uses, height, floor area ratio, and density.
 - b. Transportation, Traffic Circulation and Parking: The site has vehicular access via an existing public alley and directly accessible from West Grand Avenue. The pedestrian access for the residential tower is located along West Grand Avenue and is identified via a residential entry lobby. Loading will occur internal to the building envelope and foot print and be accessed

from an existing alley.

- c. Pedestrian Orientation. The proposed project will allow unimpeded pedestrian flow on West Grand Avenue. Residential patrons will access the residential entry lobby through West Grand Avenue.
- d. Urban and Building Design. The building's modern design emphasizes the contrast among the various types of architectural styles and vocabulary along West Grand Avenue. The building materials include an architectural composite metal panel system and a Terracotta Rain screen System. The facades are further defined with a glass window system.

The ground floor contains commercial retails space and fronts West Grand Avenue, and is enclosed by a glass storefront. The residential units are contained on two through nine with the rooftop programed for amenities and mechanical uses. The remaining elevations of the base of the building include scoured concrete and masonry, Cordova Stone ground face.

- 2. The proposed development is compatible with the character of the surrounding area in terms of uses, density and building scale. Current development north and south of the site is comprised of a mix of uses along W. Grand Avenue and further along N. Halsted Street which include residential and commercial uses. The permitted uses are allowed within the project's underlying zoning of C1-5 District.

- 3. Approved Plans. The site is identified in the Near Northwest Side Plan approved by Plan Commission on September 19, 2002, and is identified as a redevelopment opportunity site. The plan identifies this site for a mixed use building with complimentary commercial uses as the highest and best economic use for the site.
- 4. The public infrastructure facilities and city services will be adequate to serve the proposed development at the time of occupancy.

The proposed Planned Development has been reviewed by the Chicago Department of Transportation's and all requested changes have been made. Copies of this application have been circulated to other City departments and agencies and all comments received have been addressed in the revised application.

Based on the foregoing, it is the recommendation of the Department of Planning and Development that the revised application for a Residential Business Planned Development for WICKER PARK APARTMENTS, INC, be approved and that the recommendation to the City Council Committee on Zoning, Landmarks and Building Standards be: "As Amended, Passage Recommended."
