

WHEREAS, many Not For Profit Corporations own property that adjoins streets and alleys that are no longer required for public use and might more productively be used in furtherance of such activities; and

WHEREAS, the City would benefit from the vacation of these streets and alleys by reducing City expenditures on maintenance, repair and replacement; by reducing fly-dumping, vandalism and other criminal activity; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of part of public street, described in the following ordinance; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. LEGAL DESCRIPTION FOR "USC INC., AN ILLINOIS CORPORATION";



legally described by the words HEREBY VACATED on the plat hereto attached as Exhibit A, which drawing for greater clarity, is hereby made a part of this ordinance, be and the same is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacation.

SECTION 2. The Commissioner of Transportation is hereby authorized to accept and approve a redevelopment agreement or similar instrument restricting the use and improvement of the portion of public way vacated to Intrinsic Schools, an Illinois Not for Profit in Section 1 of this ordinance to social service purposes which includes, but shall not be limited to parking to serve the adjacent charter school, and for such use and improvements that are accessory, as that term is defined in the Chicago Zoning Ordinance, to such social service purposes, such uses and improvements to be owned and operated by a non-profit corporation, subject to the approval of the Corporation Counsel as to form and legality. The restriction on use and improvement in the covenant, agreement or instrument shall be for a term of 40 years and upon breach of such restriction the public way herein vacated shall revert to the City and be subject to the terms and conditions of the dedication by which it has been heretofore held by the City.

SECTION 3. The City of Chicago hereby reserves for the benefit of Commonwealth Edison, AT&T/SBC and their successors or assigns, a non-exclusive utility easement to operate, maintain, construct, replace and renew overhead wires, poles, and associated equipment and

underground conduit, cables, and associated equipment for the transmission and distribution of electrical energy, telephonic and associated services under, over and along the street herein vacated, with the right of ingress and egress. The grade of the vacated public way shall not be altered in a manner so as to interfere with the operation and maintenance of Commonwealth Edison, AT&T/SBC facilities. No buildings, permanent structures or obstructions shall be placed over Commonwealth Edison, AT&T/SBC facilities without written release of easement by Commonwealth Edison, AT&T/SBC. Any future vacation-beneficiary prompted relocation of Commonwealth Edison, AT&T/SBC facilities lying within the area being vacated will be accomplished by Commonwealth Edison, AT&T/SBC and done at the expense of beneficiary of the vacation.

SECTION 4. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, Intrinsic Schools an Illinois Not for Profit Corporation, USC Incorporated (DBA: United Building Supply Company) or their agent shall deposit in the City Treasury of the City of Chicago, a sum sufficient to defray the costs of removing paving and curb returns and constructing sidewalk and curb at the entrance to that part of the street hereby vacated in accordance with current Department of Transportation Construction Guidelines for construction of public way.

SECTION 5. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, Intrinsic Schools, an Illinois Not for

Profit

Corporation, and USC Incorporated (DBA: United Building Supply Company) shall pay or cause to

be paid to the City of Chicago as compensation for the benefits which will respectively accrue to the

owners of the properties abutting said part of public street hereby vacated the sum of *M«Ay rs.-~g. V^px/Sc^A, dollars (\$ <^\1,000) from USC Incorporated and the sum of Q] ■ dollars (\$) from Intrinsic Schools which sums in the judgment of this body will be equal to such benefits.

SECTION 6. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, Intrinsic Schools, an Illinois Not for Profit Corporation, and USC Incorporated (DBA: United Building Supply Company) shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the attached plat, and a full sized plat as approved by the Superintendent of Maps and Plats.

SECTION 7. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, Intrinsic Schools, an Illinois Not For Profit Corporation, shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois, a redevelopment agreement-complying with Section 2 of this ordinance, and approved by the Corporation Counsel.

SECTION 8. This ordinance shall take effect and be in force from and after its passage. The vacation shall take effect and be in force from and after its recording.
