### TRAFFIC LANE - TOW/AWAY ZONE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as traffic lane - tow/away zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

#### WARD TOW AWAY ZONES

1 N. Western Ave (east side) from a point 20 feet south of St. Paul Ave to a point 20 feet south thereof; No Parking Tow Zone, Except for I-Go Car Sharing Vehicles Only -- 11-01630261 [O2011-2577]

2 W. Van Buren St. (north side) from S. Aberdeen St. to a point 152 west thereof; No Parking Tow Zone, All Times - 11-02090161 [O2011-4095]

15 S. Western Ave (west side) from a point 250 feet south of W. 62<sup>nd</sup> St. to a point 25 feet south thereof; 15 Minute Standing Zone, Use Flashing Lights, 9:00 AM to 7:00 PM, Monday through Saturday -11-00380155 [O2011-878]

N. Kilbourn Ave (east side) from a point 20 feet north of W. Armitage Ave to a point 57 feet north thereof; 30 Minute Standing Zone, Use Flashing Lights, Monday through Friday 6:00 AM to 4:00 PM, Tow Zone [O2011 - 6319]

W. Erie St. (south side) from a point 214 feet east of N. Wells St. to N. LaSalle Drive; No Parking Tow Zone -- 11 -00504113 [O2011-974]

N. Clark St. (east side) from a point 222 feet north of W. Diversey Parkway to a point 20 feet north thereof; 15 Minute Standing Zone, Use Flashing Lights, 9:00 AM to 5:00 PM, Monday through Saturday, Tow Zone - 11 - 01836551 [O2011 -2794]
