8e It Ordained by the City Council of the City of Chicago:

SECTION 1:- Permission and authority are hereby given and granted to FRESH MARKET PLACE upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, six (6) Awning without Lettering or Graphics(s) projecting over the public right-of-way adjacent to its premises known as 2600 N CENTRAL AVE.

Said Awning without Lettering or Graphics(s) at N CENTRAL AVE measure(s):

One (1) at fifteen point two five (15.25) fee: in length and Zero (0) feet in width for a total of fifteen point two five (15.25) square feet.

One (1) at fifteen point two five (15.25) fee: in length and Zero (0) feet in width for a total of fifteen point two five (15.25) square feet.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1547388 herein granted the sum of one hundred seventy-ive (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City Df Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
