AG-OCG 360 NORTH MICHIGAN LLC Acct. No.

#### Se It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to AG-OCG 360 NORTH MICHIGAN LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Occupation of Space(s) under the public right-of-way adjacent to its premises known as 360 N. Michigan Ave..

#### Said Occupation of Space(s) at Lower N. Michigan measure(s):

One thousand eight hundred (1800) square feet. Existing occupation of space is used for the purpose of parking, storage of dumpsters and building operations.

### Said Occupation of Space(s) at Lower E. Wacker Drive measure(s):

Seven thousand nine hundred fifteen (7915) square feet. Existing occupation of space is used forthe purpose of parking, storage of dumpsters and building operations.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1143365 herein granted the sum of seventeen thousand eight hundred seventy-six (\$17,876.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
