#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current B3-2 Community Shopping District symbols and indications as shown on Map No. 4-H in the area bounded by:

West 21<sup>st</sup> Street; a line 276.20 feet east of South Oakley Avenue; the public alley next south of West 21<sup>51</sup> Street; a line 251.20 feet east of South Oakley Avenue

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

The subject property consists of 3,150 square feet and is improved with a 2-story building with 2 residential dwelling units and 2 automobile parking spaces. The Applicant proposes to rezone the property to a B2-3 Neighborhood Mixed-Use District in order to complete an interior remodeling to create 2 additional residential dwelling units, for a total of 4 residential dwelling units, 2 automobile parking spaces\*, 4 bicycle parking spaces, and no loading berth. The height of the building will remain at 28 feet.
