### ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 7-J in the area bounded by:**

**A line 273 feet South of and parallel to West Belmont Avenue; the public alley next East of and parallel to North Central Park Avenue; a line 298 feet South of and parallel to West Belmont Avenue; North Central Park Avenue.**

**To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District**

**SECTION 2. This Ordinance takes effect after its passage and due publication. Common**
