RECOMMENDATION TO THE CITY COUNCIL TO APPROVE A PERMIT APPUCATION FOR DEMOLITION OF A NON-CONTRIBUTING BUILDING IN A CHICAGO LANDMARK DISTRICT

WHEREAS, pursuant to Section 2-120-825 of the Municipal Code of Chicago governing review of permits for the demolition of 40% or more of any building or structure either designated as a "Chicago Landmark", or located in any district designated as a "Chicago Landmark," the Commission on Chicago Landmarks i(the "Commission") has reviewed a permit application for the proposed demolition of a:

One-story commercial building ("Building") located at 4613-4617 K Broadway within the Uptown Square District, a Chicago Landmark (the "Landmark District"); and
