ORDER

WHEREAS, pursuant to Section 2-120-825 of the Municipal Code of Chicago governing review of permits for the demolition of 40% or more of any building or structure either designated as a "Chicago Landmark", or

located in any district designated as a "Chicago Landmark," the Commission on Chicago Landmarks (the "Commission") has reviewed a permit application for the proposed demolition of a:

One-story commercial building ("Building") located at 4613-4617 K Broadway within the Uptown Square District, a Chicago Landmark (the "Landmark District"); and

WHEREAS, the significant historical or architectural features identified in the ordinance designating¹ the Landmark District are identified as: all exterior elevations, including rooflines, of the buildings visible from the public rights-of-way, therefore,

THE COMMISSION ON CHICAGO LANDMARKS HEREBY:

1. *(Finds, in accordance with the criteria for review of permit applications established in Article III of the Commission's Rules and Regulations, that the Building is non-contributing to the character of the Landmark District;*
