ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2, Neighborhood Shopping District symbols and indications as shown on Map No. 9-L in area bound by

A line 229.11 feet West of and parallel to north Lamont Avenue, Irving Park Road, north Lamont Avenue, the alley next south and parallel to West Irving Park Road

to those of a C1-1, Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.
