ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B3-2 Community Shopping District symbols and indications as shown on Map No. 4-H in the area bounded by

a line 97 feet north of and parallel to West Cullerton Street; South Leavitt Street; a line 73 feet north of and parallel to West Cullerton Street; and the alley next west of and parallel to South Leavitt Street,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A, please be informed that on or about July 21, 2021, I, the undersigned, intend to file an application for a change in zoning from a B3-2 Community Shopping District to a B2-3 Neighborhood Mixed-Use District, on behalf of the Applicant-Owner - SZP-1916 S Leavitt LLC, for the property generally located at 1916 South Leavitt Street, Chicago,

Illinois.

The subject property is currently improved with two principal buildings - a three-story three-unit residential building at the front and a three- and-half-story two-unit residential building at the rear - for a total of five (5) dwelling units at the subject site. The existing buildings are non-conforming under the current Zoning Ordinance. The Applicant is seeking a Zoning Map Amendment in order to permit the rehabilitation and conversion of the existing //on/ building - from three-units to four-units. The proposed Zoning Amendment will also bring the existing non-conforming conditions into compliance with the current Zoning Ordinance.
