### **ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the CI-2 Neighborhood Commercial District symbols as shown on Map No. 16-F in the area bounded by:**

**A line 297.00 feet south of and parallel to West 69<sup>th</sup> Street; South Wentworth Avenue; a line 346.50 feet south of and parallel to West 69<sup>th</sup> Street; and a line 133.00 feet west of and parallel to South Wentworth Avenue.**

**To those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District SECTION 2.**
