CITY COUNCIL: April 27,2022

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Section 2-8-040 of the Municipal Code of Chicago, which allows erection of honorary street designations, the Commissioner of the Chicago Department of Transportation shall take the necessary action for the Standardization of N. Paris Avenue between W. Waveland and W. Grace as "Honorary Alexandria Lialios Way".
