ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B2-3 Neighborhood Mixed-Use District symbols and indications as shown on Map No. 7-1 in area bound by

A line 72 feet East of and parallel to North Albany Avenue, West Diversey Avenue, a line 96 feet East of and parallel to North Albany Avenue, the alley next South and parallel to West Diversey Avenue.
