TRAFFIC LANE - TOW ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as Traffic Lane - Tow Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

WARD TOW ZONES:

- 1 3000 West Humboldt Boulevard; 3000 West Humboldt Boulevard (east side) from West North Avenue to West Armitage Avenue; No Parking Tow Zone, 11:00pm to 7:00pm, Tuesday and Friday, and 4:00pm to 8:00am, Sunday [02017-5063]
- 4 South Park Terrace; South Park Terrace (west side) from West Roosevelt Road to West Polk Street; No Parking Tow Zone, 9:00am to 11:00am, Monday through Friday -- (17-03310269) [02017-3915]
- 27 2345 West Monroe Street; West Monroe Street (south side) from a point 20 feet east of South Western Avenue to a point 120 feet east thereof; No Parking Tow Zone, 6:00am to 4:00pm, All Days - (16-07032378) [02016-6923]
- 27 **736 West Couch Place; West Couch Place (north side) from North Halsted Street to a point 180 feet east thereof; No Parking Tow Zone - (16-07032418) [02016-6949]**
- 39 6141 North Pulaski Road; 6141 North Pulaski Road, 20 feet north from north Driveway; No Parking Tow Zone, All Times, All Days [02017-5443]

WARD AMEND TOW ZONES:

- 15 West 47th Street; Repeal Ordinance Passed 11/14/1977, journal page 6308-6309, which reads: West 47th Street (south side) from South Western Avenue to South Damen Avenue; No Stopping, No Standing, No Parking Tow Zone, 4:00pm to 6:00pm, and 7:00am to 9:00am, Monday through Friday, by Striking the above -(17-006889140) [02017-381]
- 43 West Diversey Parkway; Repeal Ordinance which reads: West Diversey Parkway (south side) from North Ashland Avenue to North Racine Avenue; No Parking Tow Zone, 7:00am to 9:00am, Monday through Friday and West Diversey Parkway (north side) from North Ashland Avenue to North Racine Avenue; No Parking Tow Zone, 4:00pm to 6:00pm, Monday through Friday, by Striking the above [02017-5452]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
