ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS2 Residential Single-Unit (Detached House) District symbols as shown on Map No. 16-D in the area bounded by:

A line 743.29 feet north of and parallel to East Marquette Road; South Dorchester Avenue; a line 658.30 feet north of and parallel to East Marquette Road; the alley next west of and parallel to South Dorchester Avenue.

To those of an RS3 Residential Single-Unit (Detached House) District.

SECTION 2. This Ordinance takes effect after its passage and due publication.
