The grantee shall pay to the City of Chicago as compensation for the privilege #1108454 herein granted the sum of fifty (\$50.00) per annum in advance.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
