ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 5-M in the area bounded by:

West Grand Avenue; a line 150 feet East of North Melvina Avenue, as measured along the South line of West Grand Avenue and also perpendicular to West Grand Avenue; a public alley next south of and parallel to West Grand Avenue; a line 125 feet East of North Melvina Avenue, as measured along the South line of West Grand Avenue and also perpendicular to West Grand Avenue.

To those of a CI-1, Neighborhood Commercial District

SECTION 2. This Ordinance takes effect after its passage and approval.
