ORDINANCE  
NORTH AVENUE COLLECTION, LLC Acct. No.  
309283 -1 Permit No. 1114621

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to NORTH AVENUE COLLECTION, LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, seven (7) Building Projection(s) projecting over the public right-of-way adjacent to its premises known as 939 W. North Ave..

Said Building Projection(s) at W. North Ave measure(s):

Three (3) at forty (40) feet in length, and two point five (2.5) feet in width for a total of three hundred (300) square feet. Existing building projections are approximately twenty-eight (28) feet above grade level.

Said Building Projection(s) at N. Sheffield Ave measure(s):

Four (4) at forty (40) feet in length, and two (2) feet in width for a total of three hundred twenty (320) square feet. Existing building projections are approximately twenty-eight (28) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1114621 herein granted the sum of two thousand eight hundred (\$2,800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
