ORDINANCE

BE IT ORDAINED BY THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit District symbols and indicators as shown on Map No. 7-K in the area bounded by

West Diversey Avenue; North Kilpatrick Avenue; the public alley next south of and parallel to West Diversey Avenue; and a line 34.20 feet west of and parallel to North Kilpatrick Avenue.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about May 17, 2017, the undersigned will file an application for a change in zoning from RS-3 Residential Single-Unit District to B2-1.5 Neighborhood Mixed-Use District on behalf of 4701 W Diversey, LLC for the property located at 4701-4703 West Diversey Avenue, Chicago, IL 60639.

The applicants seeks the change so that they can lease the storefront unit in its property to a Cricket Mobile Phone retail store, which will obtain the proper Chicago Business License. The mixed-use building will continue to have five residential dwelling units - continuing this legally non-conforming number of units (based on the square footage and current density). B2 Zoning will allow both the existing ground-floor residential use as well as the above-requested business use. The bulk designation of 1.5 will bring the number of dwelling

units closer to conformity with the current zoning code. The property will continue to have two off-street parking spaces in a detached garage. No changes will be made to the external structure of the two-story building.
