ORDINANCE

UNIVERSITY OF CHICAGO - TIFFIN CAFE Acct.
No. 63878 - 28 Permit No. 1128778

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UNIVERSITY OF CHICAGO - TIFFIN CAFE, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Sheeting (s) under the public right-of-way adjacent to its premises known as 1414 E. 59th St..

Said Sheeting(s) at S. Dorchester Avenue measure(s):

One (1) at forty (40) feet in length, and nine (9) feet in width for a total of three hundred sixty (360) square feet. Existing sheeting is approximately thirty (30) feet in depth.

Said Sheeting(s) at E. 59th Street measure(s):

One (1) at forty (40) feet in length, and nine (9) feet in width for a total of three hundred sixty (360) square feet. Existing sheeting is approximately thirty (30) feet in depth.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation, (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1128778 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

Authority herein given and granted for a period of five (5) years from and after 07/25/2017
