ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RT4, Residential Two-Flat, Townhouse and Multi-Unit District and B3-2, Community Shopping District symbols as shown on Map No. 6-J in the area bounded by:

A line 146.01 feet North of and parallel to West 26th Street; South Christiana Avenue; West 26th Street; a public alley next West of and parallel to South Christiana Avenue.

To those of a C2-2, Motor Vehicle-Related Commercial District
