ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of the City of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3, Residential Single-Unit (Detached House) District as shown on Map No. 7-L in the area bounded by

West Fletcher Street; a line 156.02 feet east of and parallel to North Lockwood Avenue; the ally next south of and parallel to West Fletcher Street; and a line 126.02 feet east of and parallel to North Lockwood Avenue.
