# **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1: Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the Bl-2 Neighborhood Shopping District symbols and indications as shown on Map No. 13-H in the area bounded by:
