LOADING ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:

WARD	LOADING ZONES / STANDING ZONES:
3	4658 S. Martin Luther King Jr Drive; S. Martin Luther King Jr Drive (west side) from a point 25 feet north of E. 47th Street to a point 20 feet north thereof; 15 Minute Standing Zone, Use Flashing Lights, 7:00am to 3:00pm [Or2015-223]
5	1635 E. 55th Street; E. 55th Street (south side) from a point 20 feet east of S. Cornell Avenue to a point 20 feet east thereof; 15 Minute Standing Zone, Use Flashing Lights, 8:00am to 2:00am, All Days - (15-00803481) [02015-1477]
38	5230 W. Irving Park Road; W. Irving Park Road (north side) from a point 310 feet west of N. Laramie Avenue to a point 20 feet west thereof; No Parking Loading Zone, 9:00am to 7:00pm, Monday through Friday and 10:00am to 1:00pm, Saturday -(15-00934943) [02014-8694]
40	5664 N. Lincoln Avenue; N. Lincoln Avenue (west side) from a point 84 feet east of N. Fairfield Avenue to a point 20 feet east thereof; 15 Minute Loading Zone, Use Flashing Lights, 10:00am to 7:00pm - (15-00938478) [O2014-8693]
42	N. Franklin Street; N. Franklin Street (west side) from a point 20 feet south of W. Grand Avenue to a point 30 feet south thereof; 15 Minute Standing Zone, Use Flashing Lights, 5:00am to 10:00pm, All Days - (14-01324649) [02014-6420]

WARD AMEND LOADING ZONES / STANDING ZONES:

1530 S. State Street; Amend Ordinance Passed 07/29/2009, journal page 67904 which reads: S. State Street (west side) from a point 275 feet south of W. 15th Street to a point 40 feet south thereof; No Parking Loading Zone, by striking the above and inserting in lieu thereof: S. State Street (west side) from a point 275 feet south of W. 15th Street to a point 25 feet south thereof; 15 Minute Standing Zone, Use Flashing Lights, 11:00am to 12:00am, except 4:00pm to 6:00pm, All Days [02015-2701]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
