BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 7-L in the area bounded by:

The north line of West Fullerton Avenue; a line 250 feet west of and parallel to the west line of North Lamont Avenue; the south line of east-west alley just north of and parallel to West Fullerton Avenue; a line 325 feet west of and parallel to the west line of North Lamont Avenue,

To those of a C2-1 Motor Vehicle-Related Commercial District symbols and a corresponding use district is hereby established.

SECTION 2. This ordinance takes effect after its passage and due publication.
