### ORDINANCE

1408 S. WABASH DEVELOPMENT CORPORATIO Acct. No.: 480122- 1 Permit  
No: BACP1597018

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to 1408 S. WABASH DEVELOPMENT CORPORATIO upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Bay Window(s) projecting over the public right-of-way adjacent to its premises known as 1400 S WABASH AVE.

Said Bay Window(s) at 1400 S Wabash Ave measure(s):

One (1) at twenty-one point one seven (21.17) feet in length and one (1) feet in width for a total of twenty-one point one seven (21.17) square feet.

One (1) at sixteen (16) feet in length and one (1) feet in width for a total of sixteen (16) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1597018 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 09/24/2020.
