ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 9-L in the area bounded by:

The public alley next North of and parallel to West Henderson Street; a line 267.51 feet East of and parallel to North Laramie; West Henderson Street; a line 234.18 feet East of and parallel to North Laramie Avenue.

To those of an RT3.5, Residential Two-Flat, Townhouse and Multi-Unit District
