### ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the BI-1, Neighborhood Shopping District symbols as shown on Map No. 5-K in the area bounded by:**

**The public alley next North of and parallel to West Armitage Avenue; a line 33.48 feet West of and parallel to North Keeler Avenue; West Armitage Avenue; a line 58.48 feet West of and parallel to North Keeler Avenue.**

**To those of a B2-2, Neighborhood Mixed-Use District**
