TRAFFIC LANE - TOW AWAY ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as traffic lane - Tow Away Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

| 8 | E. 71st Place (south sides) from S. Stony Island Avenue to the first alley west thereof; No Parking Tow Zone [02013-6164] |
| 8 | E. 71st Place (north sides) from S. Stony Island Avenue to a point 75 feet west thereof; No Parking Tow Zone [02013-6167] |
| 19 | 2200-2330 W. 95th Street (north side only) between S. Leavitt Street and S. Claremont Avenue; No Parking Tow Zone, 8:00am to 10:00am, Monday through Friday [02014-791] |
| 19 | 1901-1959 W. 101st Street (south side); No Parking Tow Zone, 8:00am to 10:00am, Monday through Friday [02014-794] |

WARD AMEND TOW AWAY ZONES :

- 27 2400 W. Adams Street (both sides) between S. Western Avenue and S. Campbell Avenue; Repeal No Parking Tow Zone, 7:30am to 9:00am and 4:00pm to 6:00pm, Monday through Friday, [02014-787]
- 28 5000 W. Adams Street; Repeal No Parking Tow Zone ordinance passed 11/26/13, prohibiting parking in a designated area by striking therefrom the following: 5000 W. Adams Street (south side) of the street from S. Leamington Avenue to the first alley [02014-72]
- 49 1709 W. Lunt Avenue; Amend No Parking Tow Zone by striking 1709 W. Lunt Avenue, No Parking Tow Zone and inserting in lieu thereof; 1709 W. Lunt Avenue, No Parking Tow Zone, 8:00am to 8:00pm, all days [02014-797]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
