ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the MI-1, Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 2-K in the area bounded by

The alley next north of and parallel to West Taylor Street; a line 125.30 feet east of and parallel to South Keeler Avenue; West Taylor Street; and South Keeler Avenue

to those of an M2-1, Light Industry District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
