### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single Unit (detached house) District symbols and indications as shown on Map No. 12- G in the area bounded by

A LINE 316 FEET NORTH OF AND PARALLEL TO WEST 51<sup>ST</sup> STREET; THE PUBLIC ALLEY NEXT EAST OF AND PARALLEL TO SOUTH RACINE AVENUE; A LINE 291 FEET NORTH OF AND PARALLEL TO WEST 51<sup>ST</sup> STREET; SOUTH RACINE AVENUE

to those of a RT4 Residential Two-Flat Townhouse and Multi-Unit District. SECTION

2. This ordinance takes effect after its passage and approval.
