BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3, Residential Single-Unit (Detached House) symbols and indications as shown on Map No. 5-J in an area bound; by

A line 60 feet south of and parallel to West Cortland Avenue; the public alley next east of and parallel to North Pulaski Road; a line 90 feet south of and parallel to West Cortland Avenue; And North Pulaski Road

to those of a RT-4, Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.
