### ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois and as such may legislate as to matters which pertain to its local government and affairs; and

WHEREAS, the City has determined that the continuance of a shortage of affordable housing to persons of low and moderate income is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City received certain funds from the United States Department of Housing and Urban Development to make loans and grants to expand the long-term supply of affordable housing through, among other things, acquisition, new construction, reconstruction and moderate and substantial rehabilitation in low- and moderate-income areas; and

WHEREAS, the City has made a loan in the total principal amount of 2,194,227 with an interest rate of two percent (2%) per annum (the "Loan") to Maiden Place Limited Partnership, an Illinois limited partnership ("Borrower"), the general partner of which is 4520 N. Maiden, Inc., an Illinois corporation ("General Partner") pursuant to an ordinance passed by the City Council of the City on October 2, 1996 which loan consists of two separate advances occurring on (i) December 9, 1996, in the original principal amount of \$2,104,227 (the "First Loan") and (ii) March 18, 1999, in the additional principal amount of \$90,000 (the "Additional Loan"); and

WHEREAS, the Loan funds were used to provide for the acquisition of real property and the rehabilitation and construction of existing improvements into a multi-family housing residential project containing approximately 34 apartments for very-low and low income citizens by the Borrower located generally at 4520-32 North Maiden Street, Chicago, Illinois 60640 (the "Property"); and

WHEREAS, the Loan was evidenced by (i) that certain Note dated as of December 9, 1996 evidencing the First Loan and that certain Additional Note dated as of March 8, 1999 evidencing the Additional Loan (the Note and Additional Note collectively referred to as the "Note") and (ii) that certain Housing Loan Agreement dated as of December 9, 1996 made by and between the Borrower and the City as amended by that certain First Amendment to Loan Documents dated as of March 18, 1999 (the "First Amendment") made by and between the Borrower, the City, the General Partner, Anthony B. Ferguson and Gregory V. Miller (the Loan Agreement as so amended by the First Amendment is referred to herein as the "Loan Agreement") and secured by, among other things, the Loan Agreement and that certain Junior Mortgage Security Agreement and Financing Statement dated as of December 9, 1996, made by the Borrower in favor of the City (the "Mortgage"), which was made subordinate to a senior loan in the original principal amount of \$530,000 secured by a mortgage on the Property (the "Senior Loan") that was initially held by Harris Trust and Savings Bank, now BMO Harris Bank ("Harris"), and

WHEREAS, (i) the Borrower now desires to sell the Property, (ii) in order to grant permission for the sale of the Property the City, acting through its Department of Planning and Development ("DPD"), desires that Borrower take certain actions and (iii) the Borrower agrees to take said actions requested by the City, which actions shall consist of (a) upon completion of the Property sale, remitting nine-hundred thousand dollars (\$900,000) to the City in satisfaction of Borrower obligations to repay the Loan, (b) execute any and all agreements required to

extend the affordability restrictions entered into as part<sup>1</sup> of the Loan until December 9, 2018 ("Affordability Extension") and (3) to induce Lakepointe Apartments, LLC (the "Purchaser") to also execute any and all agreements necessary to acknowledge the Affordability Extension as a lien on the Property until December 31, 2018; and

WHEREAS, the City, acting through DPD, is willing to (1) accept \$900,000 payment in satisfaction of the Loan (which has an outstanding balance of \$3,066,517.80), (2) waive any additional default interest and fees which may be due under the Loan, and (3) enter into and execute such agreements and instruments as shall be necessary or advisable, to amend the terms of any documents evidencing or securing the Loan to reflect the new terms (such documents collectively referred to as the "Amendment") as approved by the Corporation Counsel of the City; and

WHEREAS, the Borrower intends to insure the Property shall be subject to the Affordability Extension;

and

WHEREAS, the Borrower has requested that the City approve a restructuring of the Loan which will accommodate the sale of the Property, the Affordability Extension and the acceptance of a payment of \$900,000 in lieu of the outstanding principal, interest (including default interest) and fees due under the Loan; and

WHEREAS, DPD desires to approve a restructuring (the "Restructuring") of the Loan in a manner which will (1) approve the sale of the Property in return for (a) the Borrower and the Purchaser entering into the Affordability Extension and (b) payment by Borrower of \$900,000 to the City; (2) accept the payment of \$900,000 from the Borrower in satisfaction of all outstanding principal, interest (including default interest) and fees due to the City under the Loan; and (3) enter into any amendment to documentation of the Loan required to implement the Affordability Extension and forgiveness of the Loan as set forth above (collectively, the "Material Terms"); now, therefore, ,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. The above recitals are expressly incorporated in. and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Amendment is hereby approved as described above. The Commissioner of DPD (the "Commissioner") or a designee of the Commissioner (each an "Authorized Officer") is hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable, in connection with the implementation of the Amendment.

SECTION 3. The Restructuring is hereby approved as described above. The Authorized Officer is hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable, in connection with the implementation of the Restructuring. The Commissioner is hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with any future restructuring of the Loan which does not substantially modify the Material Terms.

SECTION 4. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control, if any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 5. This ordinance shall be effective as of the date of its passage and approval.
