SUBSTITUTE ORDINANCE BE IT ORDAINED BY THE CITY

COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the current B3-2 Community Shopping District symbols and indications as shown on Map No. 17-11 in the area bounded by:

West Albion Avenue; North Clark Street; a line 117.44 feet south of West Albion Avenue as measured along the southwesterly line of North Clark Street; the public alley next west of and parallel to North Clark Street

to those of a B3-5 Community Shopping District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

Narrative: The Property is improved with a one-story, vacant taxi cab parking and repair facility. The Applicant proposes to rezone the property from a from a B3-2 Community Shopping District to a B3-5 Community Shopping District to demolish the building and construct a new, four-story, residential storage warehouse with approximately 2,880 square feet of ground floor commercial space. There will be nineteen parking spaces and one loading berths. The proposed height of the new building is 55 feet 3 Vi inches.
