ORDINANCE

VLAND CHICAGO 95TH LLC Acct. No.
316010-4 Permit No 1133557

Be It Ordained by the City Council of the City of Chicago

SECTION 1. Permission and authority are hereby given and granted to VLAND CHICAGO 95TH LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, five (5) Awning(s) projecting over the public right-of-way adjacent to its premises known as 2333-41 W. 95th St..

Said Awning(s) at W. 95th Street measure(s):

Two (2) at twenty-four (24) feet in length, and two point six seven (2.67) feet in width for a total of one hundred twenty-eight point one six (128.16) square feet.

Said Awning(s) at W. 95th Street measure(s):

Two (2) at sixteen point seven five (16.75) feet in length, and two point six seven (2.67) feet in width for a total of eighty-nine point four five (89.45) square feet.

Said Awning(s) at S. Claremont Avenue measure(s):

One (1) at twenty-four (24) feet in length, and two point six seven (2.67) feet in width for a total of sixty-four point zero eight (64.08) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1133557 herein granted the sum of one hundred seventy-five (\$175 00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 03/12/2018.
