ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the C1-1, Neighborhood Commercial District symbols as shown on Map No. 11 - I in the area bounded by:

The public alley next North of and parallel to West Irving Park Road; a line 197.70 feet East of and parallel to North Campbell Avenue; West Irving Park Road; a line 117.70 feet East of and parallel to North Campbell Avenue.

To those of a B2-2, Neighborhood Mixed-Use District
