ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M3-3 Heavy Industry District and B3-3 Community Shopping District symbols and indications as shown on Map No. 7-H in the area bounded by

THAT PART OF A TRACT OF LAND IN THE SOUTHEAST QUARTER OF SECTION 30, TOWNSHIP 40 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING NORTH OF THE NORTH LINE OF FULLERTON AVENUE; SOUTH OF THE SOUTHWESTERLY LINE OF CLYBOURN AVENUE; NORTH AND EASTERLY OF THE NORTH BRANCH OF THE CHICAGO RIVER AND WEST OF THE RIGHT-OF-WAY OF THE CHICAGO AND NORTHWESTERN RAILROAD, IN COOK COUNTY, ILLINOIS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE MOST EASTERLY CORNER OF A TRACT OF LAND DESCRIBED IN A WARRANTY DEED RECORDED AS DOCUMENT 3059267, SAID CORNER BEING A POINT ON THE SOUTHWESTERLY LINE OF CLYBOURN AVENUE, BEING 385 FEET NORTHWESTERLY OF THE INTERSECTION OF SAID SOUTHWESTERLY LINE OF CLYBOURN AVENUE WITH A LINE DRAWN CONCENTRIC WITH AND 15 FEET WESTERLY OF THE WESTERLY LINE OF THE 66 FEET RIGHT-OF-WAY OF THE CHICAGO AND NORTHWESTERN RAILROAD; THENCE SOUTH 49 DEGREES 25 MINUTES 01 SECONDS WEST, ALONG THE SOUTHEASTERLY LINE OF SAID TRACT DESCRIBED IN DOCUMENT 3059267, A DISTANCE OF 272.02 FEET TO THE MOST SOUTHERLY CORNER OF SAID TRACT DESCRIBED IN DOCUMENT 3059267; THENCE NORTH 40 DEGREES 33 MINUTES 39 SECONDS WEST, ALONG THE SOUTHWESTERLY LINE OF SAID TRACT DESCRIBED IN DOCUMENT 3059267, A DISTANCE OF 60.50 FEET TO A LINE PARALLEL WITH AND 60.50 FEET NORTHWEST OF THE SOUTHEASTERLY LINE OF SAID TRACT DESCRIBED IN DOCUMENT 3059267; THENCE NORTH 49 DEGREES 25 MINUTES 01 SECONDS EAST, ALONG SAID PARALLEL LINE, A DISTANCE OF 98.57 FEET; THENCE NORTH 40 DEGREES 34 MINUTES 59 SECONDS WEST, A DISTANCE OF 51.00 FEET TO A LINE PARALLEL WITH AND 111.50 FEET NORTHWEST OF THE SOUTHEASTERLY LINE OF SAID TRACT DESCRIBED IN DOCUMENT 3059267; THENCE NORTH 49 DEGREES 25 MINUTES 01 SECONDS EAST, ALONG SAID PARALLEL LINE, A DISTANCE OF 137.46 FEET; THENCE SOUTH 60 DEGREES 14 MINUTES 31 SECONDS EAST, A DISTANCE OF 2.52 FEET TO A POINT OF CURVATURE; THENCE SOUTHEASTERLY, A DISTANCE OF 4.41 FEET, ALONG A CURVE TANGENT TO THE LAST DESCRIBED COURSE, CONCAVE SOUTHWESTERLY, HAVING A RADIUS OF 4.00 FEET, A CHORD BEARING SOUTH 28 DEGREES 37 MINUTES 40 SECONDS EAST, AND A CHORD DISTANCE OF 4.19 FEET; THENCE SOUTH 02 DEGREES 59 MINUTES 11 SECONDS WEST, A DISTANCE OF 33.19 FEET; THENCE SOUTH 12 DEGREES 31 MINUTES 33 SECONDS EAST, A DISTANCE OF 6.77 FEET TO A LINE PARALLEL WITH AND 75.00 FEET NORTHWEST OF THE SOUTHEASTERLY LINE OF SAID TRACT DESCRIBED IN DOCUMENT 3059267; THENCE NORTH 49 DEGREES 25 MINUTES 01 SECONDS EAST, ALONG SAID PARALLEL LINE, A DISTANCE OF 62.08 FEET, TO SAID SOUTHWESTERLY LINE OF CLYBOURN AVENUE; THENCE SOUTH 40 DEGREES 33 MINUTES 47 SECONDS EAST, ALONG SAID SOUTHWESTERLY LINE OF CLYBOURN AVENUE, A DISTANCE OF 75.00 FEET TO THE POINT OF BEGINNING, ALL IN COOK COUNTY, ILLINOIS. 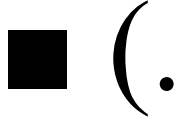

PROJECT NARRATIVE

NRG Clybourn Wrightwood, LLC is proposing the construction of a new 9,114 square foot retail building for two tenants on an existing surface parking lot adjacent to the Aldi Food Store located at 2564-2586 N. Clybourn Avenue.

The project requires a rezoning of land from M3-3 Heavy Industry zoning district and B3-3 Community Shopping District to all B3-3 Community Shopping District. This is a Type 1 application, as amended. The land was recently rezoned in 2012 to B3-3 for a Chase Bank with a drive-through operation. The project did not materialize, and the owner/applicant is now proposing a retail building for two tenants, with no drive-through.

The lot area is 23,501 square feet. The maximum Floor Area Ratio (F.A.R.) allowable is 3.0, while the actual F.A.R. will be 0.275. The proposed building height is 25'- 1". There are 16 off-street parking spaces (1 ADA), a screened trash enclosure, and 3,157 square feet of interior landscaping.

The surrounding property uses are retail. Directly south of the property is Riverpoint Center, a multi-tenant retail shopping center anchored by Dominick's (PD # 437), northwest of the property is an Aldi Food Store. East of the property is a Menards and a parking lot for Menards and west of the property is a parking lot for the adjacent retail.
