### ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 19-1 in the area bounded by:**

**The alley next north of and parallel to West Touhy Avenue; line 457.87 feet east of and parallel to North Sacramento Avenue; West Touhy Avenue; and a line 417.87 feet east of and parallel to North Sacramento Avenue.**

**To those of an RT3.5 Residential Two-Flat, Townhouse and Multi-Unit District**
