### ORDINANCE

#### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the MI-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 2-K in the area bounded by

West Polk Street;

A line 550.61 feet east of and parallel to South Kilpatrick Avenue; West Arthington Street; And South Kilpatrick Street

to those of a M2-2 Light Industry District.
