ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3, Residential Single-Unit (Detached House) District symbols as shown on Map No. 9-H in the area bounded by:

A line 150 feet South of and parallel to West Waveland Avenue; North Bell Avenue; a line 180 feet South of and parallel to West Waveland Avenue; the public alley next West of and parallel to North Bell Avenue.

To those of an RT3.5, Residential Two-Flat, Townhouse and Multi-Unit District
