ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.
Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 6- J in the area bounded by:

West 27th Street; a public alley next east of and parallel to South Ridgeway Avenue; a line 50 feet south of and parallel to West 27th Street; South Ridgeway Avenue.

To those of a B2-2, Neighborhood Mixed-Use District
