Said Awnlng(s) at WEST 26TH STREET measure(s):
One (1) at twenty-two point four (22.4) feet in length, and two (2) feet in width for a total of forty-four point eight (44.8) square feet

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and* Consumer Protection and the Office of the City Clerk.

Said privilege'shall De constructed in accordance with plans and specifications'approved by the Zoning Department- Signs.

This grant of privilege in .the public way shall be subject to the provisions of Section 10-28^015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chtcago.as compensation for the privilege #1148222 herein granted the sum of fifty (\$50.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs i associated with damage, relocation or removal of private property caused by the City performing work in the public' way.
