Said Sign structure(s) measures as follows along N. Wells Street:

One (1) at four (4) feet in length, ten (10) feet in height and twelve point seven (12.7) feet above grade le>

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs, and,Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department-. Signs.

This grant of privilege in lbe public, way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1596572 herein granted the sum of three huh

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
