# **ORDINANCE**

WHEREAS, the City of Chicago is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City of Chicago in Trust for the Use of Schools is the owner of the real estate located at 125 S. Clark Street, consisting of an approximately 34,410 square foot site improved with a 507,910 square foot building as legally described on Exhibit A, attached hereto ("Property"); and

WHEREAS, the Board of Education of the City of Chicago (the "Board of Education") recommends to the City Council of the City of Chicago the sale of said Property; and

WHEREAS, pursuant to 105 ILCS 5/34-21 (b) (1), by a vote of not less than two-thirds (2/3) of its full membership, the Board of Education has determined that such Property has become unnecessary, unsuitable, inappropriate and unprofitable to the Board of Education and that a sale would constitute the best available use of such Property for the purpose of deriving revenue to support the Board of Education's authorized purposes; and

WHEREAS, the Board of Education advertised for sale, pursuant to public notices that appeared in the Chicago Sun-Times on three (3) occasions from January 13, 2014 through March 17, 2014, and received five (5) bids (one of which was withdrawn after the completion of the due diligence period) for said Property, which bids were opened in the Department of Procurement and Contracts for the Board of Education on March 17, 2014, the closing bid date; and

WHEREAS, one appraisal was made for the Property indicating the fair market value of the Property is as follows:

Appraisal Associates As of September 23, 2014 Market Value: \$26,650,000.00; and

WHEREAS, the Board of Education has by a vote of not less than two-thirds (2/3) of its full membership at its meeting on October 22, 2014, recommended the acceptance of the bid from Blue Star Properties, Inc., located at 600 West Van Buren Street, Chicago, Illinois 60607 ("Blue Star Properties, Inc."), in the amount of Twenty-Eight Million Dollars (\$28,000,000) be accepted, which amount represents the highest bid that was submitted and not withdrawn; now, therefore,

Be It Ordained by the City Council of the City of Chicago:

Section 1. The City of Chicago hereby accepts the bid of Blue Star Properties, Inc., to purchase the Property, which Property is no longer necessary, appropriate,

required for the use, profitable to or in the best interests of the Board of Education and/or the City of Chicago.

Section 2. The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a deed conveying to Blue Star Holdings, LLC, an Illinois limited liability company, on behalf of Blue Star Properties, Inc., all rights of the City of Chicago in Trust for the Use of Schools in and to said Property.

Section 3. This Ordinance shall take effect upon its passage and approval.
