ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the B3-2 • Community Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by:

West Evergreen Avenue; North Milwaukee Avenue; a line 75.22 feet southeast of West Evergreen Avenue as measured along the southwesterly line of North Milwaukee Avenue and perpendicular thereto; a line 114.31 feet southwest of North Milwaukee Avenue as measured along the southeasterly line of West Evergreen Avenue and perpendicular thereto;

to those of a B3-3 Community Shopping District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
