THE ALLEY NEXT NORTH OF WEST 18TH STREET; A LINE 96 FEET WEST OF AND PARALLEL TO SOUTH CLINTON STREET; WEST 18TH STREET, AND; A LINE 144 FEET WEST OF AND PARALLEL TO SOUTH CLINTON STREET

To those of an B2-3 Neighborhood Mixed-Use District, and a corresponding use district is hereby established in the area above described.
